#### Filing deadline: March 3, 2017 Election date: May 9, 2017

The Milford School District anticipates two openings on the Milford School Board for 2017 for which a vote will be held. Terms are set on a five-year basis and candidates must reside in the Milford School District. The 1st opening is for an "At Large" seat and a candidate can be from any area of the Milford School District. The 2nd opening is for "Area D" which includes the Ellendale and Lincoln areas and candidate must be from one of those areas. Meetings are held at 7 PM in the multimedia room located on the west side of the former Milford Middle School main building located at 612 Lakeview Avenue, Milford, DE. If you were not pleased with the large property tax increase last year, please try to attend some of these meetings so you can find out what the School Board is planning for the rest of this school year and next year.

### Senior Citizen Tax Exemption

To all our senior citizen residents, please be advised that homeowners age 65 or over are eligible for a tax credit against regular school property taxes of 50% (up to \$500). This credit may only be used against property taxes on a primary residence. There is a 3year residency requirement for new applicants and the application deadline for filing is no later than April 30. ### **Trash Receptacles**

The HOA would like to remind all homeowners that leaving trash, yard waste or recycling receptacles on your

property in full view of the street is a violation of the Declaration of Restrictions. *Article VI, Section 6* of the Declaration reads as follows: "**Trash receptacles shall be kept in clean, sanitary and enclosed areas, hidden from view, excepting that they may be placed temporarily at street side on the regular day of collection if required by the collection agency.**"

## <u>Dog Waste</u>

Contrary to popular belief, dog feces is not fertilizer and does not provide any benefit to the soil. Dog waste was labeled a non-source environmental pollutant in 1991 by

the EPA thereby placing it in the same category as herbicides and insecticides, oil, grease and toxic chemicals much like the acid drain-age from infected mines.

The EPA states that a single gram of waste can contain up to 23 million fecal coliform bacteria which are known to cause cramps, diarrhea, intestinal illness and serious kidney disorders in humans. Not to mention the catastrophic effect the fecal coliform bacteria from dog waste has in polluting the local water table. (Resource: www.epa.gov)

In addition to cleaning up after your dog on your own

property, the HOA would like to remind all residents to also curb and clean up after your pet in all common areas and roadways in the development (including Kirby Road). Thank you for your cooperation in this matter.
