# **Grounds Committee**



With the help of board members and friends, we have been able to do a complete overhaul of the front entrance. It was a huge undertaking and we are thankful for all our volunteers. East Gate Nursery in

Milford was a huge help with the design! Tom Chilton has been extremely dedicated with watering all our new plants multiple times a week. We are still planning new stone retaining walls and an irrigation system in the near future!

The retention ponds are still looking great. Coastal Tributaries does our pond maintenance but we need your help!

Disposing of any yard waste or grass clippings into or near the ponds can cause algae to grow, in turn, costing the HOA money for remediation. More importantly, this is a violation of Delaware's Department of Natural Resources and Environmental Control (DNREC) regulations which could lead to fines for the offending party.

Planning to install solar panels, a fence, a patio, shed, deck etc.? You first must submit a completed Architectural Request Form detailing the scope of the planned project to the HOA's Architectural Committee. The fillable form is available on the HOA

Website at: <a href="www.meadowsatshawnee.com">www.meadowsatshawnee.com</a>, under the Committees/Architectural tab.

Complete the form, include a sketch of the project, use your plat (survey) map or an accurate drawing, indicating location and the dimensions of the object, and submit as indicated. You should also speak with your neighbors advising them of your plans. The application will be reviewed and you will be informed of the decision within a few days.

#### Sussex County Senior Citizen Property Tax Credit

Homeowners age 65 or over are eligible for a tax credit against their regular school property taxes of 50 percent (up to \$500). This credit may only be used against property taxes on a primary residence. To be eligible, specific qualifications must be met.

The application deadline for filing is April 30<sup>th</sup>. ## Milford's Senior Citizen Tax Exemption

A recent change to the city's Tax Code, effective November 3, 2022, raises the maximum income level for property owners age 65 or older and who meet specific qualifications may qualify for a reduction on Milford property taxes. A property owner may qualify if their income is not in excess of \$20,000 per year, or in the case of jointly owned property or property owned by husband and wife, the income of both does not exceed \$40,000 per year. Some exclusions may apply.

Keep in touch with Milford. The City's new app, **MyMilford**, enables residents to reach the City

online, or using a smartphone or tablet to request services or get help fixing issues **for non-emergency issues only**. You can use this service to report and track issues such as: Damaged Curb, Dangerous Tree, Drainage/Flooding Issue, Loose/Protruding Manhole Cover, Potholes, Power Outage (during major storms only), Sidewalk Issue, Street Light or Traffic Signal or Street Sign Issues and Trash or Recycling.

Issues related to public safety or those requiring immediate attention (wires or tree limbs down, etc.) should be reported directly to the Milford Police Non-Emergency Line at 302-422-8081.

## School's Back in Session



Daylight Savings Time ends on November 6<sup>th</sup>. It will be dark earlier when you come home, so please pay attention as you drive through our neighborhood.

Double check to make sure when backing out of your driveways or driving through the neighborhood that you have a clear view of anyone that may be in the street. Be careful, kids will be running to catch buses in the morning and getting off the bus to get home in the early evening and not always paying attention to traffic. As a driver, the burden falls upon you.

# Curb Your Dog & Pick-up Waste



Despite popular belief, dog feces is not fertilizer. The EPA categorizes dog waste as a nonsource environmental pollutant placing it in the same class as toxic waste. Be aware that all of the rain and run-off water in the MAS drains into our two ponds. So, please curb and

clean up after your dog in all common areas and the streets (including Kirby Road) in the development for a cleaner and healthier neighborhood.

## Appearance Matters!

The number of homes sold in the Meadows at Shawnee so far this year is 14 with 3 more currently under contract or pending. Houses continue to sell quickly due in a large part to our neighborhood's appearance. Help maintain your home's curb appeal by keeping trash cans out of



view, lawns mowed, do not leave grass clippings near the ponds or in the streets, remove mold and algae from siding and keep shrubs trimmed.



REMOVE MOSS, MOLD, MILDEW & ALGAE: Every 2-3 years, I spray the side of my house with "Wet It & Forget It". It eliminates using a power washer which can damage siding and be costly. See before and after pictures of a neighbor's house I

sprayed last November. Once sprayed, it takes about a month to complete the cleaning process.

## **Trash Receptacles**



As a reminder, residents are required to properly store all trash, yard waste and recycling receptacles in accordance with *Article VI*, *Section 6* of our Declaration of Restrictions: "*Trash receptacles shall be kept in* 

clean, sanitary and enclosed areas, hidden from view, excepting that they may be placed temporarily at street side on the regular day of collection if required by the collection agency."

## **Overnight Street Parking**



The HOA has always had, and continues to enforce, its restriction on overnight street parking. Article VI, Section 7 of the Declaration of Restrictions entitled "Prohibited"

**Vehicles"** requires: "...All motor vehicles owned and operated by residents of the subdivision must be parked overnight in their respective garage or driveway."

During the day, please park on the correct side of the street facing the flow of traffic. Parking on the grass is <u>not</u> allowed at any time.

These are primarily for safety! Let's keep our many walkers and bikers safe.

#### Are You Prepared? Plan Ahead for Disasters

As we already know, the 2022 Hurricane Season is upon us and winter storms will soon follow. Are you prepared to survive heavy rains, flooding and wind or heavy snow, extreme cold and wind? The Sussex County Emergency Operations Center advises that residents should prepare

by taking the following precautions: Have food, water and medications for each person in the house for 7 days; Be ready for power and phone outages; Keep mobile phones charged; Refill your gas tank(s) and stock your vehicle with emergency supplies and a change of clothes; Bring outside furniture and garbage cans inside: Have cash on hand to last 7 days. ## WHY AN HOA? -- QUESTIONS & ANSWERS

Some of our newer and longer time residents who may not have lived in an HOA community before, or don't fully understand the purpose of an HOA, have asked Board members questions like what is an HOA and what does it do? We attempt to answer these and other related questions below.

#### WHAT IS AN HOA?

HOA simply stands for Homeowners Association, a non-profit corporation dedicated to managing a commoninterest development consisting of members of a community. The main reason for creating an HOA is to preserve and increase property values. So, by definition, anyone who buys into an HOA community automatically becomes a member of that HOA with an equal share in its ownership.

#### HOW DOES AN HOA START?

After a developer creates a community, like the *Meadows* at Shawnee, they typically establish an HOA that acts as a non-profit organization. At a certain point when the community starts to grow, as specified in the corporation's By-Laws, the developer (or declarant) relinquishes full control of the HOA to the homeowners who, in-turn, then elect their Board of Directors charged with overseeing the community's operations.

#### WHAT DO HOA BOARD MEMBERS DO?

Members of the Board of Directors are homeowner volunteers elected by the Association's members with the authority to handle the day-to-day operations of the community—including managing finances, maintaining common areas, enforcing rules and regulations, collecting HOA payments, creating annual budgets and other additional duties. The duties and powers of HOA Boards are described in its By-Laws and in state law (Delaware HOAs are governed by Title 25, Chapter 81. Delaware Uniform Common Interest Ownership Act.)

To protect Board of Directors members from being held personally liable for actions made in the best interests of the HOA, the MAS HOA carries a one-million-dollar Directors and Officers (D&O) insurance policy.

#### ARE HOAS LEGAL?

Yes, HOA's are legal corporations having its own governing documents that include its Incorporation Certificate, By-Laws, and Declaration of Covenants and Restrictions.

#### WHAT ARE HOA RULES AND REGULATIONS?

HOA rules and regulations vary by association and are detailed in each HOA's By-Laws and Declaration of Covenants and Restrictions. When buying a home in an HOA, most people place value on the house and its surroundings. They want to be proud of their community's appearance. The goal of an HOA's rules and regulations is to work in unison to help protect and enhance the community's property values.
